## **REQUEST FOR EXPRESSION OF INTEREST FOR GEORESISTIVITY (GROUNDWATER SURVEY) (RE-BIDING)**

1. The CALAMBA WATER DISTRICT, through the 2016 General Funds intends to apply the sum of SEVEN HUNDRED NINETY-THREE THOUSAND EIGHT HUNDRED FORTY-FIVE PESOS (P793,845.00) being the Approved Budget for the Contract (ABC) to payments under the contract for CWD 11-2016. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
2. The CALAMBA WATER DISTRICT now calls for the submission of eligibility documents for GEORESISTIVITY (GROUNDWATER SURVEY) (RE-BIDDING). Interested consultants must submit their eligibility documents on or before 2:00 p.m. of June 14, 2016 at 2<sup>nd</sup> Floor CWD Warehouse Building, Lakeview Subdivision, Brgy. Halang Calamba City. Applications for eligibility will be evaluated based on a non-discretionary “pass/fail” criterion.
3. The BAC shall draw up the short list of consultants from those who have submitted eligibility documents/Expression of Interest and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”, and its Implementing Rules and Regulations (IRR). The short list shall consist of five or more prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:

Based on the experience of individual and overall experience of the firm and individual staff for joint venture, experience from other consulting works or firms and current workload relative to the capacity. The point system method will be used, each shall have its corresponding points and consulting firms with the highest point shall be ranked first and the next highest point as second and so forth.

4. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the IRR of RA 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

5. The Calamba Water District shall evaluate bids using the Quality-Cost Based Evaluation/Selection (QCBE/QCBS) procedure. The Calamba Water District allocated seventy percent (70%) for the Technical and thirty percent (30%) Financial Proposals. The



criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.

6. The contract shall be completed within one month counted from the day after the date of Notice to Proceed.
7. The CALAMBA WATER DISTRICT reserves the right to reject any and all bids, annul the bidding process, or not award the contract at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
8. The BAC will issue to prospective bidders Eligibility Forms at 2<sup>nd</sup> Floor CWD Bldg., Lakeview Subd., Halang, Calamba City, Laguna, upon their submission of a LOI, and upon their payment of a non-refundable amount of Five Hundred Pesos (P 500.00) to the BAC Secretariat. Prospective bidders shall submit the Eligibility Requirements to the BAC at the said address. They may also obtain the results of the Eligibility Check by the BAC at the same address.
9. The BAC will issue Bidding Documents only to bidders declared by the BAC to be eligible for the bidding upon payment of a non-refundable amount of One Thousand Pesos (P 1,000.00) to the BAC Secretariat.
