The Calamba Water District, through the 2016 General Fund intends to apply the sum of **ELEVEN MILLION FORTY-NINE THOUSAND FIVE HUNDRED SIXTY-FOUR PESOS (P11,049,564.00)** being the Approved Budget for the Contract (ABC) to payments under the contract **CWD-04-2016**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Calamba Water District now invites bids for **SUPPLY AND DELIVERY OF SUBMERSIBLE PUMPS & MOTORS, SUBMERSIBLE CABLE AND ELECTRIC CABLE**. Delivery of the Goods is required 1 to 4 weeks upon receipt of Purchase Order. Bidders should have completed, one to two years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

- Interested bidders may obtain further information from Calamba Water District and inspect the Bidding Documents at the address given below during 8:00 a.m. to 5:00 p.m..

A complete set of Bidding Documents may be purchased by interested Bidders on March 10, 2016 to 12:00 nn of March 29, 2016 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **TWENTY-FIVE THOUSAND PESOS (P 25,000.00)**

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

- The Calamba Water District will hold a Pre-Bid Conference on March 17, 2016 @ 1:30 p.m. at 4<sup>th</sup> floor Office of the General Manager Conference Room, Administration Building, Lakeview Subdivision, Brgy. Halang, Calamba City, which shall be open to all interested parties who have purchased the Bidding Documents.

- Bids must be delivered to the address below on or before 2:00 p.m. of March 29, 2016. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found.**

Bid opening shall be on 2:00 p.m. of March 29, 2016 at 2<sup>nd</sup> Floor CWD Warehouse Building, Lakeview Subdivision, Brgy. Halang Calamba City . Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.


