INVITATION TO BID FOR SUPPLY AND DELIVERY OF JANITORIAL SERVICES (8 PERSONNEL)

- 1. The CALAMBA WATER DISTRICT, through the CWD 2015 General Fund intends to apply the sum of ONE MILLION FIVE HUNDRED FORTY-FOUR THOUSAND SEVEN HUNDRED SEVENTEEN PESOS & 76/100 (P1,544,717.76) being the Approved Budget for the Contract (ABC). Payments under the contract for CWD 11-2014 for a period of one (1) year renewable up to two (2) consecutive year of satisfactory performance. Bid shall be fixed and shall not be adjusted during contract duration. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The CALAMBA WATER DISTRICT now invites bids for SUPPLY AND DELIVERY OF JANITORIAL SERVICES (8 personnel). Delivery of the Goods/Services is required by January 2015. Bidders should have completed, Six (6) months to one (1) year from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
- Interested bidders may obtain further information from CALAMBA WATER DISTRICT and inspect the Bidding Documents at the address given below during 8:00 A.M to5:00 P.M, Monday thru Friday.

A complete set of Bidding Documents may be purchased by interested Bidders on November 21, 2014 up to December 10, 2014 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of FIVE THOUSAND PESOS ONLY (P5,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

- 5. The CALAMBA WATER DISTRICT will hold a Pre-Bid Conference on November 28, 2014 @ 9:00 a.m. at 2nd floor CWD Warehouse Building, Lakeview Subdivision, Brgy. Halang Calamba City, Laguna, which shall be open only to all interested parties who have purchased the Bidding Documents.
- Bids must be delivered to the address below on or before 9:00 a.m. of December 11, 2014. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on December 11, 2014 @ 9:00 a.m. at 2nd floor CWD Warehouse building, Lakeview Subdivision, Brgy. Halang Calamba City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- The CALAMBA WATER DISTRICT reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
