WSMD commenced the Brgy. La Mesa and Barandal Water System Project

Year 2011 has been a bountiful year for Engineering Department specifically the Water System Maintenance and Construction Division (WSMD) in view of all the projects that were being implemented and the degree of accomplishments it has achieved.

WSMD recently started the implementation of *Brgy. La Mesa* (*Pasong Kalabaw*) and *Barandal Water System Project*. The project has an estimated total amount of P10 million and it consists of approximately 2.6 kilometers of transmission & distribution line including its clustering of water meters.

Apart from the transmission and distribution lines, the project also consists of the construction of two (2) pumping stations with a total capacity of 20Lps and 22Lps, respectively.

The completion of the project will expand the existing water system of CWD and will address the ever growing demand for CWD services to provide access to sufficient, safe and potable water. The system improvement is expected to address the demand of every household within the vicinity by the year 2012.














Non-Revenue Water Scaled Down in 2011

CWD bore down in its skirmish against high Non-Revenue Water (NRW) at the start of the year 2011. The District had thumped against the detrimental NRW reducing it gradually in a scaled down trend from as high as 30.10 in January to less than half towards the beginning of the last quarter of the year. In particular, the lowest figure was hit at 10.82 in June, notably increased in September at 20.49 and was pulled back down to 14.63 in October.

Beating the LWUA standard for NRW that is set at

20% is truly one of the great challenges for all local water districts. Challenged with such, the Management is always on-guard in impeding the possible causes of water loss and reducing the value of non-revenue water. As a matter of fact, new units of portable leak detector and portable meter calibration gadgets were purchased early this year. True enough, these gadgets greatly helped the Engineering Staff in efficiently detecting leaks and ensure standard calibration of water meters thus evading meter inaccuracies and guarantee accurate gauge of water consumption. In addition, reward

system for getting hold of illegal connections is constantly put into operation thus reducing, if not totally stamping out, water theft. On the average, 30 illegal connections are being apprehended every month.

A struggle against NRW was figuratively like a tug-of war, yet the District not just victoriously overstepped the target but pulled down the water losses even below the LWUA standard. Such is a mirror of efficient and effective leak management program being implemented in the water distribution system.



In the first State of the Union Address of President Noynoy, he mentioned about the water shortage problem in some parts of Manila and Quezon City. His Excellency said that despite this problem, the members of the Board of Directors of MWSS are living extravagantly with brand new cars as incentives and excessive salaries with staggering amount of bonuses. Maynilad Water Works were also blamed for this prolong and agonizing water shortage. Thus, the issuance of EO No. 7, which suspends all allowances, bonuses, incentives and other perks for members of the Board/Trustees. Unfortunately, Local Water Utilities were also affected by this chain of events because of public perception, in the thinking that LWD's are within and under the jurisdiction of MWSS, therefore its Board also receives the same lucrative incentives.

For this reason, let us evaluate and lay down the actual facts. Local Water Districts does not receive funds or any monetary support coming from national, provincial, city, or municipal government, or any governmental

institutions for that matter. It is a self-sustaining quasi-public provincial, city, or municipal government, or any governmental institutions for that matter. It is a self-sustaining quasi-public corporation performing public service and supplying public wants, in which the collection for its subsistence are coming directly from its concessionaires. The Local Water Utilities Administration (LWUA) and not MWSS exercises jurisdiction over all Local Water Districts and shall primarily be a specialized lending institution for the promotion, development, and financing of local water utilities. The functions of LWUA in terms of furnishing technical assistance including monitoring and evaluating local water standards are clearly mandated under Sec. 50 of PD 198.

Any additional allowances and benefits received by the members of the Board of Directors of LWD's shall have the approval of the LWUA based on the Board Resolution granting such allowances on top of the per diem they are already receiving. This is also in

consonance with R.A. 9286, which further amends Sec. 13 of PD 198, expressly provides that, - "Each Director shall receive per diem to be determined by the Board, for each meeting of the Board actually attended by him, but no Director shall receive per diems in any given month in excess of the equivalent of the total per diem of four meetings in any given month. Any per diem in excess of One Hundred Fifty Pesos (P150.00) shall be subject to the approval of the LWUA. In addition thereto, each Director shall receive allowances and benefits as the Board may prescribe subject to the approval of the LWUA".

Henceforth, the call for the exemption on the implementation of EO No. 7 in all local water utilities is only justifiable.

(Editor's note: Just recently, President Aquino signed into a law creating a Governance Commission for GOCC's and expressly excluded all Local Water Districts from the implementation of said Executive Order.)

In celebrating the yuletide season complete with joyful reunions and family gatherings, we should also be alert and constantly on guard against scams and other trickeries that many con artists may provide. CWD is not totally exempted from such scams, and the new Philippine Peso Bills which are not yet widely circulated is a good example for it is how being illegally duplicated. This was not the first time that certain concessionaires issued fake money for their water payments. As experienced by the Collection Section, they received counterfeit money as payment almost 3 times every six months. This is very alarming indeed. The following questions are directly from concerned CWD employees.

When a counterfeit or fake bills were presented as payment, are we obliged to return it to the payee, if he has no knowledge that the said bill was indeed fake?

No, this is to avoid the use thereof to

the prejudice and damage of another person and intentionally make it appear as true and genuine bill. A counterfeit bill received as payment should be written on the face thereon in bold letters with words like "FAKE", "COUNTERFEIT", "FORGED" or "FALSIFIED" whether or not he has knowledge thereof.

When a concessionaire was caught in possession of fake money bill, is he criminally liable? No, mere possession of false money bill, without the intent to use it, is not a criminal offense. Even if the false money was mistakenly used as payment for water bills so long as there is an absence of knowledge on the part of the concessionaire on the genuineness of the bill.

Is it important to know whether or not the payee has actual knowledge on the genuineness of the bill or any legal tender for that matter? Yes, an actual knowledge presupposes that there is a fraudulent intent to use it. Actual knowledge may be manifested on the failure of the payee to explain satisfactorily his possession of the counterfeit bills. Any response which is unsatisfactory may only mean that he is the forger himself or that he knows who falsified it, but does not want to divulge its origin.

What is the punishment prescribed by law on persons in possession thereto with intent to defraud or in connivance with forgers of such false notes or bills?

Under Par.2 of Art. 166 of the Revised Penal Code, it provides that, "By prision mayor in its maximum period (from 10 yrs. and 1day to 12 yrs. imprisonment) and a fine when the forged or altered document is a circulating note issued by any banking association duly authorized by law to issue the same." All money bills issued by the Central Bank are national bank notes.

Is there a way to spot or even detect a forged or falsified new Philippine Peso bills?

Yes, a fake, forged or falsified new Philippine Peso bills has no features or characteristics which are evident in a genuine or real peso bills, like in the following;

Optical variable inks – The ink used in selected parts of a genuine Philippine Peso bill change color when viewed in a different angle, the fake one does not have such features.

Multiple watermarks – Aside from the watermark on the face of the bill, the Central Bank has also added a watermark of every bill's respective denomination, for example, P1,000.00 bills have now watermarks in the bill itself. Just hold the bill against the light source to see these new security features.

Wider security threads – The holographic security threads are still there, but were made wider for improved visibility. It also changes colors when viewed from different angles.

Embossed bill wordings – The title of the bill and the "Republika ng Pilipinas" phrase is lifted above the bill and clearly distinguishable even by just the feel of the hand.

Vividly colored – Genuine bills are very vivid and has vibrant colors. It doesn't look dull, light or faded. Color contrast and hue are definite giveaways when spotting the fake ones.

With that, it is important to note that we should not be complacent in our dealings with concessionaires especially if we are in the receiving end, not only in terms of receiving water bill payments but also in our dealings with other creditors because this is money we're talking about here, whether in small or large amount.

Make-Over for GSIS

There are many challenges that the new set of members of the Board of Trustees of the Government Service Insurance System (GSIS) may undergo in terms of changing the widely practiced structural system of one of the most unpopular agencies of the government. Its like putting up a major by-pass operation and a dose of antidotes just to cleanse this primary social insurance governmental institution. But the new members of the Board which is the governing and policy-making body of GSIS are determined to eradicate the past misdeeds by putting up a new system and reforms that will promote and radically change the general perception and thus revive the confidence of the public.

As a social insurance institution, GSIS insures its members against the occurrence of certain contingencies in exchange for their monthly premium contributions. We all know that social security benefits available for all GSIS members are: compulsory life insurance, optional life insurance, retirement benefits, disability benefits for work-related contingencies, and death benefits. It goes to the old saying that retirement benefits are not privileges but are right, for the simple reason that the retirees contribution which they will inevitably receive is in fact their hard-earned money.

The changes in the system were already enforced by the new administration such as the deployment of more Wireless Automated Processing System (G-WAPS) kiosk

nationwide, including an additional 500 kiosk that can be used by all active members. The old practice when it comes to retirees that they should always be physically present in claiming their pensions is now an old myth. Their existing records are all linked to the NSO, meaning they can now follow-up and receive their claim even without their physical appearance before the GSIS. In the past, a dependent of a retiree may not receive a survivorship pension if he is gainfully employed but now a dependent with or without a permanent job may still receive such pension. Also, any retiree or active member who filed a complaint before any division of GSIS may now be resolved within 60 days and cases which have been archived or pending for years shall be reopened for final resolution. In addition thereto, unlike before, retirees may now receive their membership claim on both GSIS and Social Security System (SSS) retirement benefit plan, as long as the said retirees have been members of GSIS for 15 years and SSS for 10 years.

There is also a plan to put up a regional GSIS center here in Calamba City, which can benefit the active members, retirees and pensioners. Any questions pertaining to all claims, loans, memberships, benefits, contributions, pensions, including the on-going reforms and changes within GSIS can be addressed or directly raised before the Regional Center. The existing problem that should be resolve immediately is the anomalous and controversial data base project with IBM. GSIS confirmed that they fired their Senior Vice President Edilberto Ocampo, who is alleged to have entered into an illegal deal with technology firm IBM Philippines and systems integrator Questronix. This system program which crashes that started in March of 2010, had caused delays in the processing of members in their claims and benefits. Those who will be affected are hoping for the final closure of this case.

Finally for GSIS, extreme make -over is worth waiting.







It was 1996 when Calamba Water District established the Provident Fund in accordance with the Administrative Order No. 279 (Prescribing Rules and Regulations for the Establishment and Administration of a Provident Fund of Agencies Covered By Section 41 of the General Provisions of Republic Act No. 7180). Its purpose is to serve as savings and loan facility that will cater to the needs of regular employees and to provide the retirement or separation benefits when they retire, been disabled, separated from the service and in the event of death, the payment of definite amount to their legal, valid and authorized beneficiaries. Its existing implementing guidelines were crafted in accordance with the Executive Order No. 641 dated July 25, 2007.

At present, the CWD Provident Fund is being managed by its Board of Trustees and officers, as follows:

Likewise, the growth of the Fund may not have been possible without its support committees such as Membership and Development Committee, Loan Evaluation Committee and Financial Management and Investments Committee.

It was only last year, 2010, when the CWD Provident Fund granted bereavement benefits to the members who are legal, valid and authorized beneficiaries. Premonition it may seem, on that same year, one of the advocators of the said benefit, the late Carlo O Rodriguez, who was one of the members of Board of Trustees as well, was the very first to benefit from it due to his untimely demise. Nonetheless, his endeavor to provide better lives for the protection and welfare of the members of the fund shall always remain, being the primary objective of the said Fund.

At present, the Fund is offering various types of loans that serve as immediate answer to financial problems and uplift the members' economic state.

However, the CWD Profund Board of Trustees decided that all non-moving accounts must be repaid based on the amount of loan and on the borrower's capacity to pay in order that the financial viability of the Fund would not be sacrificed. Nevertheless, the interest earned on employee's share also known as dividend is given every year among the members of the said Fund.

Moreover, the CWD Board of Directors approved a resolution as recommended by the Fund's Board of Trustees implementing the increase of member's employee-employer share. Said share, which remained constant at 3%-10% since the inception of CWD Provident Fund in 1996, increased by 2% or is now tantamount to 5%-12% shares. Such was on the view that this will benefit the members especially upon retirement.

Presently the Provident members continuously grow its numbers, from a mere 78 in 1996 to 209, as of October 2011.

The grant of scholarship programs to the members' legal, valid and authorized beneficiaries is also one of the Fund's future plans that will surely pave the way for additional comfort zone to its members.

latter in exchange for seedlings. Various species of fruit bearing trees seedlings are nurtured in the Nursery Plant so as to propagate and grow, while some were being donated to different Non-Government Organizations that hold tree-planting activities as well.





DMT has just begun!

Aside from being on call during calamities, the Disaster Management Team (DMT) of Calamba Water District (CWD) is also aiming to protect the water source from bacteriological and other chemical contamination by promoting Solid Waste Management.

The onslaught of numerous typhoons made us realize that the reason for floods, mudflows and soil erosion are mostly the piles of garbage that we disposed of improperly, which eventually goes down to the drainage system, canals and waterways. Hence, the Team did various activities in consonance with the AKAP Campaign for disaster prevention:

AWARENESS - Distribution of flyers regarding campaign on anti-littering and other vital information relative to dealing with calamities as well as possible prevention of its adverse effects. An Audio Visual Presentation, which will educate the community on various effects of improper garbage disposal, shall be prepared by the team to be presented during community outreach.

KNOWLEDGE – In order to equip the team with the proper "know-how", trainings and seminars are lined - up for the DMT members particularly those who are assigned in the Medical and Rescue Team.

Likewise, last October 15, the team joined forces in cleaning the Bucal Spring, which is the major source of CWD water. The Team also tied-up with the Philippine Red Cross for the seminar-workshop on Basic Life Support which was held on December 1-2, 2011.

All of these are just the beginning of a mission for carrying out the District's social responsibility for the city milieu, hoping to encourage a positive impact to the employees, environment, concessionaires as well as the entire Calamba community.


