AMENDMENTS TO BIDDING DOCUMENTS

Under Section I. Invitation to Bid. Paragraph 2. Section III. Bid Data Sheet, ITB Clause 20.2. Section VI. Schedule of Requirements. Section VII. Technical Specifications, should be read as follows:

I. Under Section I. **Invitation to Bid. Paragraph 2,** should be read as follows:

2. The **CALAMBA WATER DISTRICT** now invites bids for the above Procurement Project. Delivery of the Goods is required within **One (1) Month/as per advised of End-user upon receipt of Purchase Order.** Bidders should have completed, within **one (1) year** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

II. Under Section III. **Bid Data Sheet, ITB Clause No. 20.2,** should be read as follows;
