SPECIFIC

Security Guard:

1. Guards must be 23 to 40 years old, at least 2nd year college with one to two (1-2) years' experience, trustworthy, physically, mentally and emotionally fit, well-

trained of good moral character with no criminal record and have their commissions and/or licenses to carry firearms in their possession at all times while on duty. The Calamba Water District (CWD) may request at any time to inspect commissions/ licenses to make sure the posted guards are properly commissioned. Guards not conforming to this requirement may not be allowed on premises until they have secured proper licenses. The Security Agency shall be responsible for this condition at all times.
