### AMENDMENTS TO BIDDING DOCUMENTS

Present and Previous Supplier of Calamba Water District must secure a Certificate of Completion/Good Standing on the Delivery of Contract for Goods within Five (5) Years if applicable.</li><li>4. Latest six (6) month's income tax returns filed and paid through the BIR Electronic Filing and Payment System (eFPS)</li><li>5. Latest two (2) quarter's business tax returns (VAT Payments) filed and paid through the BIR Electronic Filing and Payment System (eFPS)</li><li>6. Copy of Certificate of Notarial Commission of the Notary Public issued by the Regional Trial Court.</li></ul>

Notarized authorization to the Calamba Water District-Bid and Awards Committee, Technical Working Group for the verification of the following at the BIR Office (Regional Office) attached with photocopy of two (2) valid Identification Cards with signature of the signatory;</p> <ul style="list-style-type: none"> <li>• Latest Income and Business Tax Return (VAT Payment) within the last six months preceding the date of bid submission, and</li> <li>• Payment Confirmation</li> </ul> <p>8. <b>Notarized Affidavit of Sworn Statement that the Bidder/Supplier has an ongoing development of similar project in a particular Water District</b></p>
