## 1. I. BUSINESS MATTERS:

- 1. There being a quorum, the pre-bid conference for the Supply of Services of an Event
- 2. Organizer for CWD Company Outing and Team Building 2019 (Bidding) (CWD 10-
- 3. 2019) started at exactly 10:02am on April22, 2019, at the 2nd Floor of CWD Warehouse

- 4. Building, Lakeview Subdivision Halang Calamba City, Laguna.
- 5. Ms. Carreon led the Prayer invoking for Divine Guidance.
- 6. The Chairman has discussed that the target date of the company outing and team building is
- 7. June 7-8, 2019. And that the area is Club Balay Isabel Talisay Batangas.
- 8. The body was informed that invitations were sent to Laguna Chamber of Commerce and
- 9. Industry, Pansol Tourism Society and Commission on Audit to act as observers in the
- 10. proceedings but no one attended the meeting.
- 11. Mr. Cartago likewise informed the body of the prospective bidders listed in the Philgeps
- 12. document request list.
- 13. The presence of the BAC Members and Officers, Special Events Committee Members and
- 14. the prospective bidder were acknowledged by the Chairman.
- 15. It was also noted that the project was posted to Philgeps dated April 15, 2019 and will close
- 16. on May 6, 2019 with an ABC of Php 1,756,900.00.
- 17. The prospective bidder was reminded that the scheduled opening of bids is May 6, 2019 at
- 18. 9:00am; to submit the documentary requirements ahead of the opening date to avoid
- 19. disqualification due to late submission of bids.
- 20. The Chairman has informed that the total number of employees was not indicated in the
- 21. invitation. However, the ABC is intended for 250 employees.
- 22. It was discussed that a bid bulletin will be issued for the exact number of participants which
- 23. will be based on the result of the survey being conducted.
- 24. The Vice Chairman has emphasized that the bid proposal shall be on a per-head basis.
- 25. An orientation with the participants was suggested as to the amenities of the venue for
- 26. familiarization.
- 27. The Chairman has also informed the body that an addendum shall be issued for the venue

- 28. which shall state "Club Balay Isabel Talisay Batangas".
- 29. Engr. Gillera has suggested making the bid proposal separately for venue and transportation.
- 30. The prospective bidder was once again reminded that one (1) copy original document and
- 31. three (3) copies of the original document with signature of the authorized representative on
- 32. each page must be submitted.
- 33. It was likewise emphasized by the Chairman that the original document shall prevail; that a
- 34. pass/fail criteria shall be observed.
- 35. In addition, it was discussed that pages number two (2) and three (3) of the Philgeps platinum
- 36. membership must be submitted for verification of the expiration of pertinent documents.
- 37. Moreover, propose sealing and markings must be observed according to the BAC Chairman.
