1. I. BUSINESS MATTERS:

- 1. There being a quorum, the Pre-Bid Conference for the Supply and Delivery of Submersible
- 2. Pumps and Motors including Supply of Splicing Kit and Accessories (Bidding) (CWD
- 3. 52-2018) was called to order at exactly 03:10 P.M on November 13, 2018, at the 2nd Floor of
- 4. CWD Warehouse Lakeview Subdivision Halang Calamba City.
- 5. Ms. C. Elepaño led the Prayer invoking for Divine Guidance.

6. MEETING PROPER:

- 7. The BAC Chairman acknowledged the presence of the prospective bidders.
- 8. It was explained that only projects pertaining to submersible pumps together with the
- 9. End user's acceptance or official receipt shall be accepted for similar projects.
- 10. On the other hand, it was clarified that if the contract for the similar project contains other
- 11. items, the amount of submersible pumps must be at least 50% of the ABC of the project
- 12. being bid.
- 12. A question was raised if it is possible adjust the required similar project done to within five (5)
- 13. years.
- 14. Engr. Gillera has notified the body that a corresponding bid bulletin will be issued upon
- 15. thorough discussion with the BAC if necessary.
- 16. It was also discussed that a board resolution and secretary certificate issued to the authorized
- 17. representative must be submitted during the purchase of the bidding documents.
- 18. Also, it was clarified that a pass/fail criteria will be observed; that bids must be submitted on
- 19. or before the scheduled time of opening of bids.

- 20. On technical specifications the prospective bidders were advised to further examine
- 21. the required dynamic head meters to be able to make the necessary modifications through a
