

2. There being a quorum, the **pre-bid conference for the Supply and Delivery of Goods,**
3. **Catering Services and Raffle Prizes for CWD's Year-End Activity (Rebidding) (CWD**

17. through the BAC Secretariat within the allowable period as prescribed under RA 9184.
