TERMS OF REFERENCE FOR WATER ANALYSIS

DIVISION 1: MICROBIOLOGICAL ANALYSIS

- 1.1 Monthly collection of Twenty Six (26) water samples for City Health monitoring done every third week of every month
- 1.2 Assigned laboratory will provide the 26 bottles for water sampling for each every collection
- 1.3 CWD laboratory personnel will collect the 26 samples and the assigned laboratory will pick up the collected samples in CWD laboratory
- 1.4 If in any case, there is a positive sample, recheck of sample is free of charge
- 1.5 Release of water analysis is on the following week of every collection and it should be mailed or delivered to CWD laboratory free of charge.

DIVISION 2: PHYSICAL AND CHEMICAL ANALYSIS

- 2.1 Semi-annual collection of all pump stations will be collected by the CWD Laboratory personnel and will then be pick up by the assigned Laboratory
- 2.2 First and second batch will be 64 samples respectively, tests must comply
 The Standard Parameters set by the DOH (13 parameters including BENZENE If
 any case the scheduled collection will be postponed, schedule of collection of samples will be
 agreed by both parties
- 2.3 Sampling bottles will be provided by CWD laboratory
- 2.4 Release of results is after a week of examination which will be mailed or delivered in the CWD laboratory free of charge

DIVISION 3: ARSENIC ANALYSIS

- 3.1 ARSENIC test monitoring, a special test done every quarter of the year, Two (2) samples collected on specified area which will be collected by CWD laboratory personnel and will then be sent out by CWD personnel to assigned laboratory
- 3.2 Sampling bottles will be provided by CWD laboratory
- 3.3 Release of results is after a week of examination which will be mailed or delivered in the CWD laboratory free of charge
