1. The Calamba Water District, through the 2015 General Funds intends to apply the sum of **NINE HUNDRED FIFTY-SIX THOUSAND SEVEN HUNDRED NINETY-NINE PESOS & 96/100 (P956,799.96)** being the Approved Budget for the Contract (ABC), payments under the contract for CWD-16-2015. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Calamba Water District* now invites bids for **SUPPLY AND DELIVERY OF LIQUEFIED CHLORINE GAS (Re-bidding)**. Delivery of the Goods is required on second week of August 2015. Bidders should have completed, one to two year from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
4. Interested bidders may obtain further information from Calamba Water District and inspect the Bidding Documents at the address given below during office hours from 8:00 a.m. to 5:00 p.m.

A complete set of Bidding Documents may be purchased by interested Bidders on June 10, 2015 to 10:00 a.m. of June 29, 2015 from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of **ONE THOUSAND PESOS (P1,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

5. The Calamba Water District will hold a Pre-Bid Conference on June 17, 2015 @ 9:00 a.m. at 2nd Floor Warehouse Building, Lakeview Subdivision, Brgy. Halang Calamba City, which shall be open only to all interested parties who have purchased the Bidding Documents.
6. Bids must be delivered to the address below on or before 10:00 a.m. of June 29, 2015. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on 10:00 a.m. of June 29, 2015 at 2nd floor CWD Warehouse Building, Lakeview Subdivision, Brgy. Halang Calamba City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. The Calamba Water District reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
