### Invitation to Bid

#### **SUPPLY OF LABOR AND MATERIALS FOR INSTALLATION OF WATER DISTRIBUTION LINE AT ST. AUGUSTINE SUBDIVISION, BRGY. LAWA CALAMBA CITY**

1. The **CALAMBA WATER DISTRICT**, through the CWD 2015 General Fund intends to apply the sum of **THREE MILLION SEVENTEEN THOUSAND THIRTY-TWO PESOS & 44/100 (P3,017,032.44)** being the Approved Budget for the Contract (ABC) to payments under the contract for CWD 19-2015. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **CALAMBA WATER DISTRICT** now invites bids for **SUPPLY OF LABOR AND MATERIALS FOR INSTALLATION OF WATER DISTRIBUTION LINE AT ST. AUGUSTINE SUBDIVISION, BRGY. LAWA CALAMBA CITY**. Completion of the Works is required in **twelve (12) months**. Prospective bidder must have an experience of having completed at least one (1) contract that is similar to the contract to be bid, and whose value, adjusted to current prices using the NSO consumer price indices, must be at least fifty percent (50%) of the ABC to be bid: Provided, however, That contractor under Small A and B categories without similar experience on the contract to be bid may be allowed to bid if the cost of such contract is not more than fifty percent (50%) of the Allowable Range of Contract Costs (ARCC) of their registration based on the guidelines as prescribed by the PCAB.

Moreover, a contract shall be considered "similar" to the contract to be bid if it has the same major categories of work.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from **CALAMBA WATER DISTRICT** and inspect the Bidding Documents at the address given below from 8:00 A.M. TO 5:00 P.M. Monday thru Friday.
5. A complete set of Bidding Documents may be purchased by interested Bidders from June 11, 2015 up to 12:00 n.n. of June 30, 2015 the address below and upon payment of

a nonrefundable fee for the Bidding Documents in the amount of FIVE THOUSAND PESOS (P5,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

6. The CALAMBA WATER DISTRICT will hold a Pre-Bid Conference on June 18, 2015 @ 2:00 p.m. at 2<sup>nd</sup> Floor CWD Warehouse Building, Lakeview Subdivision, Brgy. Halang Calamba City, which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be delivered to the address below on or before June 30, 2015 @ 2:00 p.m., 4<sup>th</sup> Floor Conference Room, Office of the General Manager, Administration Building, Lakeview Subdivision, Brgy. Halang Calamba City. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The CALAMBA WATER DISTRICT reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
